SUBJECT: **Supplemental Traffic Enforcement Program
Quarter Ending June 30, 2017**

During the three-month and twelve-month periods ending June 30, 2017 CHP issued 167 (84 for unsafe speed) and 440 (245 for unsafe speed) citations, respectively. The numbers of citations for the previous three-month and twelve-month periods ending March 31, 2017 were 95 (52 for unsafe speed) and 369 (214 for unsafe speed). CHP also gave 209 verbal warnings and assisted 149 motorists during the quarter. The citations are presented by type in the attached pie charts. Number of citations for the 19 general locations (12 locations identified by a 2006 DMFPO survey, plus 7 locations added based on the feedback and field observations) are presented on the attached maps.

The four mobile speed monitor/display units have been rotated among 12 pre-determined locations during the quarter. The average speeds in most residential zones remain near or below 25 mph with the exception of sections of the Forest Lodge, Sloat, Lopez, Forest Lake Roads; and Crespi Lane. The average and 85% speeds on those highly travelled roads remain near or below 30 mph, and 35 mph, respectively.

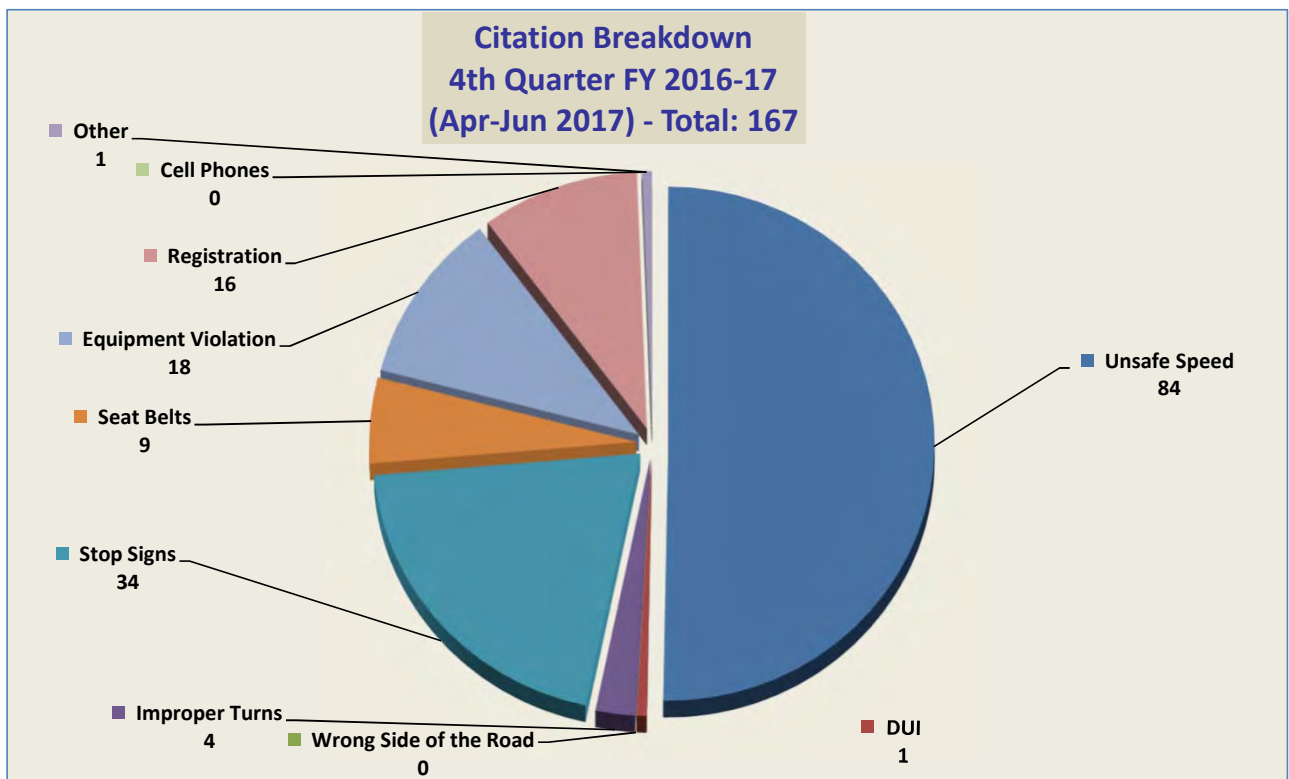
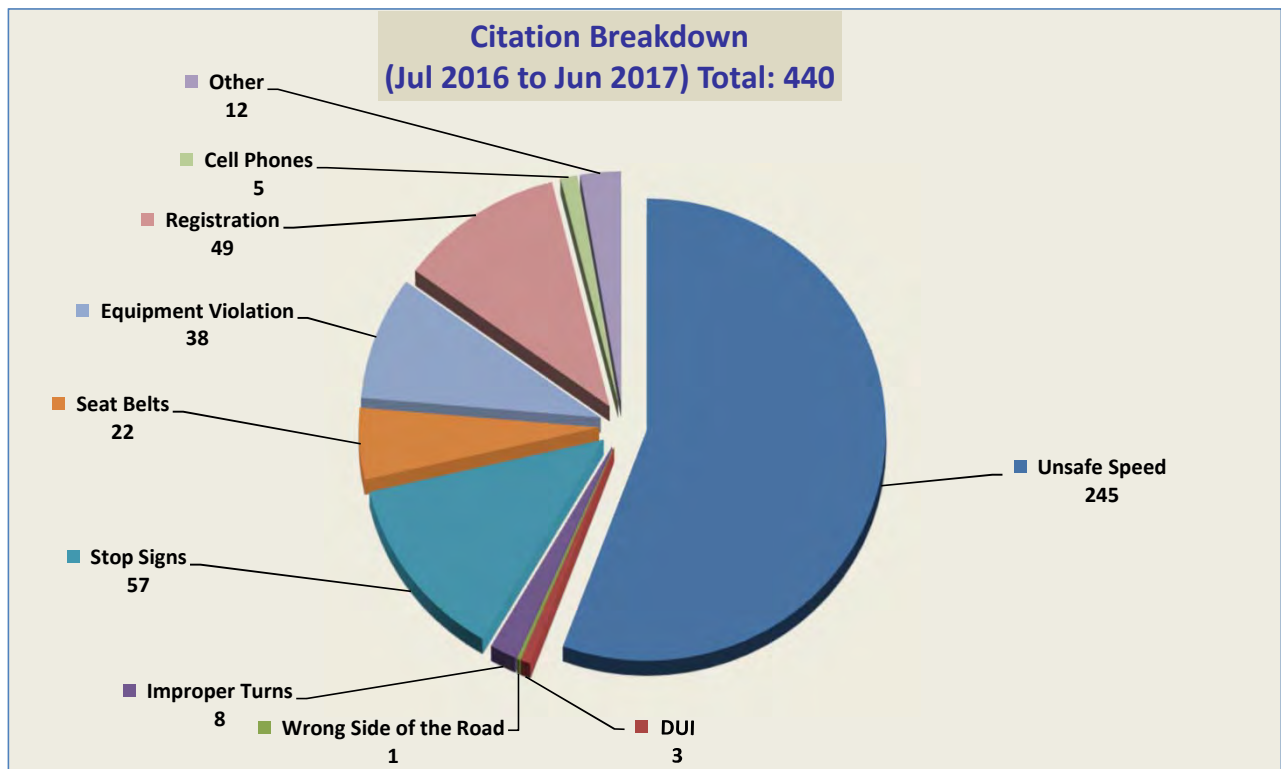
- 1) Vehicle traffic and speed statistics at locations with higher recorded speeds.
