Lower Poppy Trail is difficult to find and needs trail markers.

Chair Ogle relayed Kelly Getreu's request for a safer crossing for horses on the Blue Trail at Congress Road above Forest Lake Reservoir. Ms. Mathes did not think equestrians were using that portion of the trail due to the dangerous conditions, especially if there is more than one horse. Mr. Niccum suggested rerouting the trail somewhere in the area of the PBCSD district offices.
